Your submission provides the Office of Cannabis Management (OCM), the Cannabis Control Board (CCB), and the public with the information necessary to make informed licensing decisions.

The Marijuana Regulation & Taxation Act allows for a public referendum on any local opt-out law and gives all opt-out municipalities the ability to opt-in at any future date. These local laws will not be tracked elsewhere and in the real time necessary for decision-making. To that end, localities that are reversing a local opt-out law need to inform OCM and the CCB of the change utilizing the same form on the OCM website. Please be sure to file any updates in a timely manner.
