

## Ossian Town Board Minutes

- Purpose:** Regular Board Meeting

- Call to Order:** The Regular Board Meeting of the Ossian Town Board was called to order by Supervisor Knapp at 7:30 pm.
- Pledge to Flag** The pledge to the flag was led by Councilman Jaegar
- Approval of Minutes:** The minutes for the January 11, 2022 Regular Board Meeting were presented. Supervisor Knapp corrected the minutes by adding the Yearend Meeting of December 28, 2021 to the minutes that were approved. Councilman Jaegar moved to accept the January 11, 2022 minutes as corrected. Councilman Patane seconded the motion. Carried.
- Communications:** Supervisor Knapp reported that the 2022 Seniorama is to be held on Saturday May 7, at the WillowCreek Venue. No Ossian nominee as of now. He also read a thankyou card from Steve Rauber thanking the Town Board for his retirement party.
- Financial Report:** The Financial Report for January 2022 was distributed by the Supervisor. Total receipts were \$258,652.85 and total disbursements were \$80,027.35. there is one correction under fines which should read \$125.00 instead of \$225.00. Councilman Mark moved to accept the Financial Report as presented with corrections. Councilman Jaegar seconded the motion. Carried.
- Claims:** Highway claims #123 through #137 totaling \$26,139.84 and General Fund claims #115 through #137 totaling \$ 23,792.47 were presented for payment. Councilman Patane moved to accept all claims as presented. Councilman Jaeger seconded the motion. Carried.
- Reports:** Town Clerk VanHeusen reported a total business for September 2020 of \$224.00. The Towns share is \$222.00 which is presented to the Supervisor.  
Code Enforcement Officer Bourgoine informed the Board that he issued 1 building permit and 1 use variance  
Assessor Smalt reported that she has been working on exemptions and working on field reviews for the update for 2022 Tax season.  
Highway Superintendent Young reported that they have been plowing and sanding roads. He will also be attending a meeting regarding CHIPS.  
Judge Wilson is on vacation no report for this month.

**Other Business: Highway Superintendent Young reported that the right to farm Signs are in and will be put up when the weather permits.**

Snyder Brothers sent a new fee schedule for grave openings and will be Charging \$ 400.00 per opening and charging \$100.00 per hour over Time. These costs will be incurred by the Plot owner. The current cost For a grave site is \$500.00.

**Auditing of the Supervisor, Town Clerk, and Town Justice Books took place. Upon review, Councilman Mark moved to accept the financial records for all three as being found to be true and accurate to best of our ability. Councilman Jaeger seconded the motion. Carried.**
