**Other Business** Received the new Fire Contract from the Village of Dansville for 2023.

Councilman Mark moved to authorize the Supervisor to sign the contract for Fire Protection. Councilman Pero seconded the motion. Carried. Local Law 1 of 2023. The CEO and Town Attorney will discuss the wording and present it to the Town Board at the January10, 2023 regular Board Meeting. Cyber Security was discussed and are waiting for more information to be presented at the January10, 2023 meeting. Also the Agreement to Spend Highway funds has to be done at the January10, 2023 Board Meeting. The Year end meeting will be held on December
